#### **1. Economic Rights**

\* The exclusive right to reproduce, distribute, and communicate recordings of their performances to the public \* The right to receive royalties from the exploitation of their recordings

#### 2. Moral Rights

\* The right to be identified as the performer in connection with the use of their recordings \* The right to prevent the distortion or mutilation of their recordings

#### 3. Related Rights

\* Neighboring rights, which grant performers special protection against unauthorized broadcasting, public performance, and the making of derivative works based on their recordings




